

The Annual Fees and Charges at Erasmus Primary School are set by the Board of Governors annually.

## Tuition Fee

The Annual Tuition Fee is set on the basis that parents may provide a maximum of 6 hours of service each week during school terms. The objective of the Family Participation Program\* is for parents to engage with and become involved in their child's school, as well as making the Annual Tuition Fee more affordable.

Families commencing after the start of the school year will pay a pro-rata rate on Tuition Fees and Additional Charges, except the Facilities Levy and Books, which are charged at the full amount.

## \*Family Participation Program

The Family Participation Program provides parents an opportunity to engage and become involved in their child's school. The school can keep fees relatively low, by parents contributing up to 6 hours per week, per child, towards maintenance upgrades and activities at the school. Alternatively, parents pay a fee in lieu of participating in this program.

- Participation is a serious commitment and considered part of enrolling at school and paying school fees.
- It is the responsibility of parents to ensure that they fulfil their commitment.
- Parents may choose the work they wish to do from a list of available tasks. The Family Participation Program tasks available are determined by the school's needs and include: Kitchen, Laundry, Table Setting, Maintenance, Gardening and Library.
